RESOLUTION

WHEREAS, Public Works and Planning – Development Services Org 43600200 will receive a grant in the amount of \$310,000 from the California Department of Housing and Community Development, Planning Grants Program for preparation, adoption, and implementation of plans that streamline housing approvals and accelerate housing production; and

WHEREAS, said monies are not included in the FY 2019-20 appropriations and estimated revenues of the Public Works and Planning Org 43600200; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Public Works and Planning Org 43600200 as follows:




