WHEREAS, the Alternate Indigent Defense Services Organization 2875 requires an increase in appropriations in the amount of \$650,000 due to an increase in court appointed claims and ancillary fees associated with the conflict defense agreement; and

WHEREAS, \$650,000 of Unassigned Fund Balance is available in the General Fund 0001 to fund these expenditures; and

WHEREAS, said monies were not included in the adopted appropriations for the FY 2019-20 Alternate Indigent Defense Services Organization 2875; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;


