WHEREAS, at its October 23, 2018, hearing the Fresno County Board of Supervisors
considered the Agenda Item with attachments including the Planning Commission Staff Report, the
proposed amendment, the Planning Commission's resolution, verbal and/or written public testimony on
the proposed amendment; and

WHEREAS, the amendment of the General Plan consisted of re-designating the land use of two adjacent parcels totaling 4.15 acres from Rural Density Residential to Limited Industrial; and

WHEREAS, the Board adopted Resolution No. 18-381, which amended the Fresno County General Plan as proposed by GPA No. 552; and

WHEREAS, following the Board's approval, Forgotten Fresno, a group of nearby residents, challenged the project approvals by filing a Petition for Writ of Mandate and Complaint for Declaratory and Injunctive Relief with the Fresno County Superior Court; and

WHEREAS, the applicant, Fresno Humane Animal Services, decided to no longer proceed with the project, or develop an animal shelter; and

WHEREAS, all parties decided to resolve the litigation via the Stipulation and Order in which the entitlements granted by the County would be repealed and rescinded and the complaint filed by Forgotten Fresno would be dismissed.

NOW, THEREFORE IT IS HEREBY RESOLVED that the Fresno County Board of Supervisors hereby adopts Resolution rescinding Resolution No. 10-381, dated October 23, 2018, which amended the Agriculture and Land Use Element of the Fresno County General Plan by re-designating two adjacent parcels totaling 4.15 acres from Rural Residential to Limited Industrial.
