

**SUMMARY OF ORDINANCE**  
This Ordinance amends Chapter 10.42, entitled "Residency Restrictions for Registered Sex Offender," of Title 10, entitled "Public Peace, Morals and Welfare," of Part VII, entitled "Offenses by and against Minors," of the Ordinance Code of Fresno County by repealing Chapter 10.42 in its entirety and reserve Chapter 10.42 for future use.
