This Ordinance authorizes the County Administrative Officer or Director of Internal Services/Chief Information Officer to negotiate and execute in the name of the County, as lessee, all leases and licenses of real property with private entities or governmental agencies which the County may require, subject to the provisions prescribed in Government Code section 25350.51.
