WHEREAS, the Social Services Fund 0065, Welfare Advance Fund Organization 1120 will receive \$17,494,134 in Federal and State funds to meet the need as Operating Transfer Out to Aid to Families with Dependent Children-Foster Care Organization 6410, Aid to Adoptions Organization 6415, and California Work Opportunity and Responsibility to Kids Organization 6310; and

WHEREAS, said monies are not included in the FY 2019-20 adopted appropriations and estimated revenues of the Welfare Advance Fund Organization 1120; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Welfare Advance Fund Organization 1120 as follows:


