WHEREAS, the Local Revenue Fund 2011 Fund 0271, Protective Services Subaccount Organization 6210 will receive \$2,450,362 from the State of California as part of Sales Tax collected and distributed as dictated by state law to meet the need as Operating Transfer Out to Dependent Children- Foster Care Organization 6410; and

WHEREAS, said monies are not included in the FY 2019-20 adopted appropriations and estimated revenues of the Protective Services Subaccount Organization 6210; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Protective Services Subaccount Organization 6210 as follows:


