WHEREAS, the Sheriff-Coroner-Public Administrator (Org) 3111 will receive \$300,000 as an Operating Transfer In from the Sheriff-Coroner Special Revenue Fund Org 1467, Fund 0095, Subclass 17666 for the purchase of a Handheld Mass Spectrometer, pay overtime expenses as well as miscellaneous services needed to carry out case operations; and

WHEREAS, said monies are not included in the FY 2019-20 adopted appropriations and estimated revenues of the Sheriff's Organization 31116378; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Sheriff-Coroner-Public Administrator ORG 31116378 as follows:


