Increase the 2019 VAWA funds by \$26,881 from \$202,545 to \$229,426;
Increase the 2019 VAWA match by \$8,960 from \$67,515 to \$76,475;
Increase the Total Project Cost by \$135,029 from \$270,060 to \$405,089.
Change the end of Performance Period of the Subaward for the following funds 2018 VAWA and 2019 VAWA funds from 06/30/2020 to 12/31/2020.

The 2018 VAWA funds in the amount of \$74,391 must be expended first and before 2019 VAWA funds.
