WHEREAS, the Social Services Fund 0065, Subclass 17240, Emergency Homelessness  
Funding Grant Org 1135 will receive \$1,883,713 to meet unanticipated expenses associated with  
COVID 19 emergency homelessness for FY 2019-20; and

WHEREAS, said monies were not included in the FY 2019-20 adopted appropriations and  
estimated revenues of the Emergency Homelessness Funding Grant Org 1135; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these  
funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is  
authorized to increase the appropriations in the FY 2019-20 Emergency Homelessness Funding  
Grant Org 1135 as follows:




