WHEREAS, the County of Fresno will receive \$53,722 from the State of California,
Office of Emergency Services, 2019 Coverdell Forensic Laboratory Program; and

WHEREAS, the County of Fresno, Sheriff-Coroner-Public Administrator's
Organization 3111 will receive \$43,000 as an Operating Transfer In from the Sheriff's
Special Revenue Fund 0095, Criminalistic Laboratory Fund, Subclass 17651,
Criminalistic Lab Fund Org 1451; and

WHEREAS, said monies are not included in the FY 2019-20 adopted appropriations
and estimated revenues of the Sheriff-Coroner-Public Administrator's Org 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation
of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax
Collector is authorized to increase the appropriations in the FY 2019-20 Sheriff-
Coroner-Public Administrator's Org 3111 as follows:


