

## **Suspension of Competition Acquisition Request**

- 1. Fully describe the product(s) and/or service(s) being requested.
  - On May 19, 2020, County staff discovered flooding in the North Annex Jail. The flooding was determined to have been caused by inmates flushing personal and commisary items down the main drain. To prevent the potential for further damage, a declaration of emergency was made by the Director of Internal Services/Chief Information Officer in conjunction with the County Administrative Officer. This allowed service contractors to conduct remediation and restoration activities immediately.

  Multiple vendors as needed.

Current projections are \$600,000.

  - Due to the water damage of the North Annex Jail areas, an emergency was declared to protect County property and equipment from additional damage.
