APPLICATION NO. V19-06)

WHEREAS, the Director of the Department of Public Works and Planning informs this Board that the Department initiated the process to vacate the public road right-of-way of South Barton Square (AKA Calwa Alley), located East of the intersection of South Barton Square and East Barton Square and more accurately described as a portion of Lot 1 of Barton Addition to Calwa, in the County of Fresno, State of California Recorded July 23, 1946, in Volume 13 of Maps at Page 5, Fresno County Records, approximately 4,038 Square Feet (Vacation Application No. V19-06); and

WHEREAS, the Department of Public Works and Planning reviewed the Fresno County General Plan and the proposed vacation, including the location, purpose, and extent of such proposed vacation, and reported in the Agenda Item for July 7, 2020, that the proposed vacation is consistent and in conformity with the General Plan; and

WHEREAS, the Department of Public Works and Planning recommends the following:

(1) That the Board of Supervisors declares its intent to hold a hearing pursuant to Chapter 3 of Part 3 of Division 9 of the Streets and Highways Code (collectively, the "Vacation Laws") for the proposed vacation of the right-of-way more particularly described in Exhibit A. A map showing the proposed vacation is on file with the Clerk of the Board.

(2) That the vacation procedure be conducted under the Vacation Laws.

(3) That a public hearing be set to consider the vacation of said right-of-way.

(4) That the Board of Supervisors consider the report of the Director of the Department of Public Works and Planning and make a finding that the proposed vacation is consistent and in conformity with the General Plan, pursuant to Government Code section 65402, subdivision (a).

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors to:

(1) Adopt the foregoing recitals as true and correct.

1 (2) Direct the Clerk of the Board to publish for at least two successive weeks prior to the
2 hearing, a notice of intent to vacate, and direct the Department of Public Works and Planning to
3 post notice of the same, pursuant to the Vacation Laws.

4 (3) Set the public hearing to consider vacation of said right-of-way for the hour of 9:00 a.m.
5 on August 4, 2020 in the Chambers of the Board of Supervisors, Room 301, Hall of Records,
6 Tulare and "M" Streets, Fresno, California.

7 (4) Consider the report of the Director of the Department of Public Works and Planning on
8 the proposed vacation in order to make a determination whether it is consistent and in
9 conformity with the General Plan, pursuant to Government Code section 65402, subdivision (a).


