\*The Census Office will provide direction if there are additional tracts that may require outreach support.

Our efforts through October 31, 2020 will focus on collaboration among all Census outreach partners to maximize resources and prioritize outreach activities in low responding census tracts. The Census Office is providing your organization additional funding in the amount of \$100,000 in consideration for additional scope of work activities through October 31, 2020 as specified below.

The additional funding is provided to support the following NRFU outreach priorities:

- Targeted outreach activities by tracts as specified above
- Support language access in the designated tracts
- Support health and safety measures
- Support phone Banking, text campaigns, and direct mail
- Targeted localized media/communication tactics (i.e., paid, digital, geofencing, over-the-top, radio, Out of Home locations, business and organization partnerships that uplift local trusted messenger voice(s), customized messaging and creative content)

Your Regional Program Manager will provide additional direction during weekly calls, emails, or guidance letters. On a weekly basis, your organization is required to update into SwORD activities conducted using the additional funding. All other contract requirements, duties, obligations and deliverables remain in place

If you agree to receive and use the additional funding in support of the abovelisted funding priorities, you must submit this acceptance letter no later than **July 30, 2020**.

Please contact your Regional Program Manager as soon as possible if this deadline cannot be met. As a reminder, your contracts currently state in Exhibit D, Special Terms and Conditions, that "Contractor shall not expend any State or local government funds for anything other than CCC-approved outreach activities." As we approach the General Election, we wanted to highlight how this would apply to election activities:

Contract funds may not be used to support other contracts or activities, including other campaign activities, political activities or business activities. To prevent confusion regarding the census, all outreach activities should be approached in a nonpartisan manner. Outreach field staff should take precautions to avoid doing census outreach alongside

with outreach activities in support of a candidate running for an elected office or in support of partisan political issue. This does not preclude conducting outreach activities alongside nonpartisan "voter education" activities, including voter registration activities and preparation and distribution of certain voter guides so long as these activities are conducted in a non-partisan manner.

We look forward to responding your response no later than July 30, 2020.
