

## **Suspension of Competition Acquisition Request**



- Fully describe the product(s) and/or service(s) being requested.
  - Due to the congregate setting at the Fresno County Jail facillities, and potential for rapid transmission, the Interim County Health Officer recommended an initial round of COVID-19 testing over a four-week period to assess the extent of exposures and mitigate risk to inmates and staff. Ongoing COVID-19 testing is required to ensure the safety of all persons potentially affected, however, it is not operationally feasible to utilize current County resources for the expected testing needed for County staff and contractors working in Fresno County Jail facilities.
  - The Testing consists of a testing kit and a medical procedure for each affected County employee conducted weekly and certain contractor employees on a one-time basis.
- Identify the selected vendor and contact person; include the address, phone number and e-mail address for each. The selected vendor is Pinnacle Training Systems, LLC. - What is the total cost of the acquisition? If an agreement, state the total cost of the initial term and the amounts for potential renewal terms.
  - The intial term of the agreement runs from July 9, 2020 through December 30, 2020. The total, maximum cost of this agreement, if fully utilized, is \$2,665,600 which is comprised of \$140 per test provided for 750 North Jail employees per week for the 25 weeks of the agreement for a maximum total of \$2,625,000, AND one round of tests at \$140 per test for each of the 290 employees of a county contractor for a total of \$40,600.
- Identify the unique qualities and/or capabilities of the service(s) and/or product(s) that qualify this as a Suspension of Competition acquisition.
  - Due to the urgency of the COVID-19 pandemic, and due to the recommendation of the Interim County Health Officer to begin COVID-19 testing immediately, and due to the limited availability of County staff to address the urgency of the needed testing, and due to the lack of available contractors that have the capacity and appropriate insurance requirements to conduct these tests equitably, Pinnacle Training Systems, LLC. as a referred vendor from a current County contractor, demonstrated the requirements mentioned and the capacity to provide the needed testing immediately.

When the contract is with a federal, state, or local governmental agency. - Due to the COVID-19 pandemic and the ongoing spread of COVID-19 in the Fresno County Jail facilities, the County is in need of testing services for staff working in its jail facilities. The testing ensures mitigation efforts are made to slow further exposure and spread of the COVID-19 pandemic.
