## FIRST AMENDMENT TO AGREEMENT

2	THIS FIRST AMENDMENT TO AGREEMENT (First Amendment) is made and entered		
3	into this 4th day of August , 2020, by and between the County of Fresno		
4	(OWNER or COUNTY) and Kitchell Capital Expenditure Managers, Inc. (CONSULTANT).		
5	WITNESSETH:		
6	WHEREAS, the COUNTY and CONSULTANT entered into an Agreement dated		
7	December 16, 2014 identified as Agreement No. 14-736, incorporated herein by reference (the		
8	Agreement), for CONSULTANT to provide construction management services for the Wes		
9	Annex Jail project; and		
10	WHEREAS, the Agreement provided for a maximum compensation amount of		
11	\$4,800,247, with \$3,723,852 of that amount allocated to Basic Fee Services, and \$1,076,39		
12	allocated to Extra Services; and		
13	WHEREAS, OWNER and CONSULTANT now desire to increase the maximum Extra		
14	Services allocation payable under the Agreement by an additional \$579,739; and		
15	WHEREAS, the increase is required in order to provide adequate compensation to		
16	CONSULTANT to provide construction management staff for an additional 29 week extension		
17	of the construction schedule and anticipated project completion date contemplated by the		
18	parties at the time the Agreement was entered into by CONSULTANT; and		
19	WHEREAS, approval of this First Amendment will increase the maximum amount		
20	payable to CONSULTANT for Extra Services to \$1,656,134, and will increase the maximum		
21	Total Fee amount payable to CONSULTANT to \$5,379,986; and		
22	NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of		
23	which is hereby acknowledged, the parties agree as follows:		
24	1. That existing County Agreement No. 14-736, Article IV, Section A, Page twenty-		
25	three (23), Lines twenty-one (21) through twenty-three (23) is hereby deleted in its entirety and		
26	replaced with the following paragraph:

"Notwithstanding any other provision in this Agreement, the Total Fee (Basic Fee and Extra Services Allocation) for the services required under this Agreement shall not exceed a total amount of \$5,379,986."

2. That existing County Agreement No. 14-736, Article IV, Section C, Page twenty-four (24), Line twenty-four (24) beginning with the word "There" and ending on Page twenty-five (25), Line three (3) with the word "exceeded" is hereby deleted in its entirety and replaced with the following paragraph:

"There will be an additional maximum allocation of \$1,656,134 to pay for authorized Extra Services. Payment of Extra Services in excess of \$1,656,134 is unauthorized and can only be made pursuant to a prior written amendment to this Agreement when the cumulative total of the Basic Fee and Extra Services allocation would thereby be exceeded. The COUNTY Representative shall have the discretion to adjust in writing the Basic Fee and Extra Services limits as long as the total Agreement amount of \$5,379,986 is not exceeded".

All other terms, conditions, mutual covenants, and promises contained in the Agreement, shall remain in full force and effect, except as hereinabove amended by this First Amendment. COUNTY and CONTRACTOR agree that this First Amendment is sufficient to amend the Agreement and that upon execution of this First Amendment, the Agreement and this First Amendment shall together be considered the Agreement.

The Agreement, as hereby amended, is ratified and continued. All provisions, terms, covenants, conditions and promises contained in the Agreement, and not amended herein, shall remain in full force and effect.
