

1 **FIRST AMENDMENT TO AGREEMENT**

2 THIS FIRST AMENDMENT TO AGREEMENT (hereinafter "Amendment") is made and entered
3 into this 26 day of August, 2020, by and between COUNTY OF FRESNO, a Political Subdivision of
4 the State of California, Fresno, California (hereinafter "COUNTY"), and FRESNO ECONOMIC
5 OPPORTUNITIES COMMISSION, a California non-profit public benefit organization, whose address is
6 1920 Mariposa Mall Suite 330, Fresno, California, 93721 (hereinafter "CONTRACTOR").

7 **WITNESSETH:**

8 WHEREAS, COUNTY and CONTRACTOR entered into Agreement number D-20-316, dated
9 August 19, 2020, (hereinafter "Agreement"), pursuant to which CONTRACTOR agreed to provide
10 community outreach and support services related to the COVID-19 pandemic to COUNTY; and

11 WHEREAS, COUNTY and CONTRACTOR now desire to amend the Agreement in order to
12 correct a clerical error made in the body of the agreement related to the stated maximum
13 compensation, which will result in the body of the agreement being consistent with the budget set forth
14 in Exhibit B to the Agreement.

15 NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which
16 is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

17 1. That "\$3,910,658.00" located in Section Five (5), Paragraph B, Line 25, on page Five
18 (5) of the Agreement is deleted and replaced with "\$4,039,556.00".

19 The Agreement, as hereby amended, is ratified and continued. All provisions, terms,
20 covenants, conditions and promises contained in the Agreement and not amended herein shall remain
21 in full force and effect.


