6	EMERGENCY DUE TO TREE MORTALITY AND DEGRADED
7	FOREST CONDITIONS
8	WHEREAS, California's national parks and managed forests are important natural
9 10	resources and tourist attractions for millions of visitors from California, the United States and around the world, and serve a significant role in the California economy; and
11	WHEREAS, the preservation of California's natural resources, including trees and forests, conservation of upper watershed areas, promotion of better air quality, the educational opportunities trees and forests offer, the promotion of tourism, and the creation of sustainable is are all in the best interest of the public; and
12

14	increased insect infestation, trees on both public and private lands are dying at unprecedented rates, with tree mortality rates ranging between 20% and 85% in several areas of the state and
15

18	WHEREAS, the unprecedented tree mortality disaster will adversely affect the
19	watersheds that supply over half of the water used in California, dramatically increase the risk large wildfires, diminish air quality, disrupt the food cycle, and result in increased mortality rate
20	for wildlife; and
21	WHEREAS, the tree mortality disaster in eastern Fresno County has contributed to recent devastating wildfires which have resulted in an adverse effect on our environment, economy, and public well-being; and
22	
23	WHEREAS, present local, statewide, and federal resources are inadequate to address
24 25	proper forest management, watershed protection, and the effects of this tree mortality disaster;
25	and
27	WHEREAS, the timely removal of dead and dying trees on public and private lands is necessary in order to help protect and maintain watersheds and wildlife habitat, protect and
28	restore forest resiliency, protect tourism and educational opportunities, and create jobs in rural communities.
29	NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors that a
30	Local Emergency exists throughout Fresno County and that said Local Emergency shall be
31	deemed to continue to exist until its termination is proclaimed by the Board of Supervisors; and

1	IT IS FURTHER RESOLVED AND REQUESTED that the Governor of the State of
2	California request a Presidential Declaration of Emergency for Fresno County; and
3	IT IS FURTHER RESOLVED AND REQUESTED that the State of California facilitate
4	and support interagency coordination across local, state and federal levels to promote access to resources such as expertise, equipment and human resources that are necessary to remove,
5	store (where appropriate) and dispose of dead and dying trees using economically and environmentally sustainable methods in order to restore forest and watershed health; and
6	
7	IT IS FURTHER RESOLVED AND REQUESTED that the State of California coordinate with federal and local agencies to ensure that financial assistance is available to address
8	immediate threats to public safety and to expand, develop and make available financial tools for
9	public lands, property owners and businesses to develop capacity to reduce and manage these threats; and
10	IT IS FURTHER RESOLVED that a copy of this Proclamation be forwarded to the
11	Governor of California and State Director of the Office of Emergency Services; and
12	IT IS FURTHER RESOLVED that the County Administrative Officer, acting as Director of
13 14	the Office of Emergency Services, hereby designate a representative of the County of Fresno authorized for the purpose of, but not limited to, assessing damage, consulting with federal
15	and/or state survey teams regarding hazard mitigation actions, processing and coordination of
16	all inquiries necessary to obtain financial and human resources available for state and federal assistance.
