The Department of Social Services is seeking services which include housing search and placement (Housing Navigation Services), case management, direct financial assistance, and housing stabilization services for families currently in the child welfare system experiencing or at risk of homelessness for the Bringing Families Home Program. All services provided must be integrated with the family's Child Welfare case plan to support family reunification efforts and reduce the number of children placed in foster care.

Four Hundred Eight Thousand, Two Hundred Seventy-Five and No/100 Dollars (\$408,275), for a period of twenty-two (22) months commencing Sept.22, 2020 through and including June 30, 2022.

Centro La Familia Advocacy Services (CLFA) currently administers the California Work Opportunity and Responsibility to Kids (CalWORKs) Housing Support Program (HSP) on behalf of the Department. They are experienced in providing the required services for families and can expedite implementation and minimize administrative costs by utilizing experience, as well as processes and staff already in place for HSP to maximize direct financial assistance to clients and align processes between CalWORKs HSP and BFH.
