Dear Fresno County Board of Supervisors:

My name is Rosemary Gomez and I am an immigration attorney at California Rural Legal Assistance ("CRLA") Foundation – Fresno. I live and work in District 3. On behalf of CRLA Foundation, I submit this comment to express deep concern with the continued entanglement between our Sheriff's Department and Immigration and Customs Enforcement (ICE) and demand accountability from the Board.

CRLA Foundation is a statewide organization with a focus on serving rural, low-income, and largely Latino communities throughout California's Central and Northern Valleys. Our immigration unit provides comprehensive immigration representation to all undocumented community members regardless of criminal history. We conduct a number of consultations and legal orientations with detained individuals on a monthly basis.

Through these consultations, I have encountered Latino males with low-level offenses who were transferred from Fresno County jail to the custody of ICE. In fact, a majority of the individuals I consult with are in immigration detention because of their contacts with the criminal justice system. Many of them are ultimately released on bond by an Immigration Judge because they are not considered a danger to the community. Now more than ever, in the middle of a pandemic, confinement of migrants is unjust and inhumane. I am disappointed in our county for contributing to the population of immigration detention facilities.

Moreover, it is clear our Fresno County Sheriff cannot be trusted with public safety when she does everything in her power to undermine state law protections for our migrant community. In the past, she has published inmates' release dates and/or an immigrant detainer hold status on a public portal. Such information facilitates the transfer of all county jail inmates without legal status to ICE custody, including those whom the Sheriff is prohibited from transferring.

Local law enforcement cooperation with immigration erodes public trust in our local institutions and leads to racial profiling of Latinos. Thus, I urge the Board to (1) take action to halt the Department's current practices now (2) defund law enforcement and (3) prioritize investing in the health and wellness of our diverse community.
