THEREFORE, the parties agree as follows:

AGREEMENT

1. Section Two (2) - Initial Term - of the Agreement is deleted in its entirety and replaced with the following:

"2. Term of Agreement. CONTRACTOR shall perform said Services between March 15, 2018 and December 31, 2021, at which point the parties will have the option to renew this agreement."

COUNTY and CONTRACTOR agree that this Amendment Two is sufficient to amend the Agreement and, that upon execution of this Amendment Two, the Agreement, Amendment One and this Amendment Two together shall be considered the Agreement. The Agreement, as hereby amended, is ratified and continued. All provisions, terms, covenants, conditions and promises contained in the Agreement and not amended herein shall remain in full force and effect.
