WHEREAS, the Superior Court has committed to reimburse Probation Org 3432 for staff salaries and benefits expense incurred to provide a full-time Probation Officer and a part-time Probation Technician in the Driving Under Intoxication (DUI) Treatment Court; and

WHEREAS, said monies are not included in the FY 2020-21 adopted appropriations and estimated revenues of the Probation Org 3432; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 Probation Org 3432 as follows:




