6	WHEREAS, the Director of the Department of Public Works and Planning informs this		
7	Board that the Department initiated the process to vacate the public road right-of-way of Nor		
8	Plumas Road lying between Lots 14 and 17 of Map of Kings River Thermal Tract Subdivision		
9	through 24 of said map, together with that portion lying 20 feet East of and adjacent to Lots		
10	No.41 through 48 of said map recorded in Book 7, Page 3 of Plats of Fresno County Records,		
11	approximately 2.339 Acres (Vacation Application No. V19-10); and		
12	WHERES, the Department of Public Works and Planning reviewed the Fresno County		
13	General Plan and the proposed vacation, including the location, purpose, and extent of such		
14	proposed vacation, and reported in the Agenda Item for November 24, 2020, that the propose		
15	vacation is consistent and in conformity with the General Plan; and		
16	WHEREAS, the Department of Public Works and Planning recommends the following:		
17	(1) That the Board of Supervisors declares its intent to hold a hearing pursuant to Chapter		
18	3 of Part 3 of Division 9 of the Streets and Highways Code (collectively, the "Vacation Laws")		
19	the proposed vacation of the right-of-way more particularly described in Exhibit "A." A map		
20	showing the proposed vacation is on file with the Clerk of the Board.		
21	(2) That the vacation procedure be conducted under the Vacation Laws.		
22	(3) That a public hearing be set to consider the vacation of said right-of-way.		
23	(4) That the Board of Supervisors consider the report of the Director of the Department of		
24	Public Works and Planning and make a finding that the proposed vacation is consistent and in		
25	conformity with the General Plan, pursuant to Government Code section 65402, subdivision (a).		
26	NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors to:		
27	(1) Adopt the foregoing recitals as true and correct.		
28	(2) Direct the Clerk of the Board to publish for at least two successive weeks prior to the		

1	hearing, a notice of intent to vacate, and direct the Department of Public Works and Planning to		
2	post notice of the same, pursuant to the Vacation Laws.		
3	(3) Set the public hearing to consider vacation of said right-of-way for the hour of 9:00 a.m.		
4	on December 15, 2020 in the Chambers of the Board of Supervisors, Room 301, Hall of		
5	Records, Tulare and "M" Streets, Fresno, California.		
6	(4) Consider the report of the Director of the Department of Public Works and Planning on		
7	the proposed vacation in order to make a determination whether it is consistent and in		
8	conformity with the General Plan, pursuant to Government Code section 65402, subdivision (a).
