

SUMMARY
NOTICE is hereby given that at its regularly scheduled meeting on January 26, 2021, the Fresno County Board of Supervisors adopted Ordinance No. 21-003, an Ordinance of the County of Fresno, State of California.
SUMMARY OF ORDINANCE
The purpose of the ordinance change is to correct reference to Section 03.08.100 of Title 3 of the Fresno County Ordinance Code. Section 03.08.100, previously known as Section 176 - Removal, Suspension, or Reduction in Rank of Permanent Employee, was deleted sometime after 1976. Section 03.08.100 of Title 3 was deleted due to the adoption of Personnel Rule 10 - Disciplinary Actions, however, reference to deleted Section 03.08.100 can still be found in Section 03.08.130 - Noncounty employment prohibited. This action would correct this oversight by removing said reference and replacing with new and up to date language.
