Dear Fresno County Supervisors:

Our coalition of groups dedicated to civic engagement, democracy reform, and Fresno County communities stands ready to aid Fresno County's 2021-2022 redistricting process. As you know, district lines have enormous power. Redistricting can keep people with common interests, identity, language, and history bundled together so they can effectively advocate for themselves and make their voices heard in local affairs. Or it can gerrymander them and silence their voices. To that end, we hope to see a Fresno County redistricting process that is as fair, as independent, as accessible, and as inclusive as possible.

We are writing today to state our recommendations and requests for the Fresno County redistricting process.

### Commission

1. Adopt an independent redistricting commission to maximize public trust and participation in the County's redistricting process.

### Meetings and Public Input Hearings

- 1. Prior to selecting a map-drawing consultant/demographer, hold at least one public meeting at which the options for the map-drawing consultant/demographer are discussed.
- 2. Prior to finalizing an outreach plan, hold at least one public meeting at which the County's draft outreach plan is discussed.

- 3. Hold at least one public input hearing in each existing district prior to the drawing of draft map(s), to ensure that transportation barriers do not pose an issue for any attendees and to ensure that every part of the County has a hearing where its views are prioritized and centered. If hearings are virtual, dedicate at least one virtual hearing to each existing district.
- 4. Hold at least four public input hearings after the drawing and release of draft map(s).
- 5. Ensure that members of the public can watch and participate in all public meetings and public input hearings both in-person and online.
- 6. Ensure that all public meetings and public input hearings offer live translation in at least Spanish, Hmong, Punjabi, and American Sign Language. Ensure that all materials and documents associated with public meetings and public input hearings are translated into Spanish, Hmong, and Punjabi, and that the translated version of materials and documents are released at the same time as materials and documents in English.
- 7. Ensure that all public meetings and public input hearings are accessible to people with disabilities, including closed captioning for online formats.
- 8. Ensure that hearings are held at times of day and days of the week that allow working people to attend, e.g. weeknights and weekends.

### Map-Drawing Consultant/Demographer

 Mandate that map-drawing consultant/demographer hired by the County commits in their bid/proposal to provide the community with accessible in-person and online opportunities to submit public input and proposed maps, and to provide the community with simple online mapping tools.

#### Outreach and Community Education

- 1. Do robust community education. Outreach as widely as possible to community leaders and organizations. Meet community members and community organizations where they are and in the languages they speak in order to engage them in this process.
- 2. Leverage trusted community partners and ethnic media in order to engage hard-to-reach communities.

#### **Funding**

1. Provide adequate funding and personnel to accomplish the goals listed above.




- Decennial Census is conducted each decade to count the total population







The League of Women Voters is concerned about the haste with which the staff is encouraging the Board to take action on selecting the type of redistricting commission. We believe that if you do things right at the beginning by choosing a more inclusive process you alleviate the risk of litigation or certainly the prospect of losing in the event of litigation. The Fair Maps Act (2019) requires increased transparency in the process and increased community participation throughout.

Our preference is for an Independent Commission similar to the statewide Citizens Redistricting Commission. However whichever type of commission is selected it is important to have **more than five members** on the panel. Each of them should meet **the eligibility criteria** set out in Appendix A of the staff report. In addition a budget should be considered for outreach activities – according to the CA Constitution these expenditures can be reimbursed by the state for costs mandated by the state.

The delay in data being available for use by the commission provides an opportunity for outreach activities in determining the wishes of Fresno County residents. Once the data is available there will be a short window for processing that data so public hearings may be less convenient apart from those mandated by the Fair Maps Act.

It is critically important that you include your constituents in the 2020 redistricting process from beginning to end. The staff recommendation, which you've received, to appoint an Advisory Redistricting Commission of 5 citizens, each member selected by a supervisor who stands to benefit from that person's work, is short-sighted. Citizens are sensitive to the kind of "stacked deck" that a small advisory commission, selected by you, implies.

The reason California is a leader in redistricting is that the state legislature understands the importance of impartial redistricting. We, in Fresno County also deserve impartiality. Regardless of the type of commission you resolve to form, you must adopt additional qualifications for the members of the redistricting commission, such as those indicated on the staff report, Attachment A, under "Hybrid Or Independent Redistricting Commission." Citizens who work to draw new supervisorial district lines cannot benefit from those new districts in the short term.

You have nearly 6 months before the census data needed for redistricting will be available. #### 2021 Redistricting Process

The County staff report recommends establishment of an advisory redistricting commission. This commission would be five members of the public, with one member representing each supervisory district. This would be the same model used in the 2011 redistricting process with some changes, such as an updated guideline for selecting commission members.

- 1. The timeline for this important, once in a decade process for establishing a redistricting process has been unnecessarily rushed. There has been very little time between the release of the staff report and the April 13 BOS meeting. The public has had very little time to become aware of the process and express its views on how the redistricting commission should be structured. It is premature to recommend a timeline for public outreach before the public has had a chance to weigh in on how it wants the redistricting commission to be structured. Since the 2021 Fresno County census data will be available until October, there is time to consider options for structuring the redistricting commission.
- 2. The staff report contains very little discussion of why the advisory redistricting commission is recommended over the other two options presented- a hybrid redistricting commission or an independent redistricting commission.

It would be best for the Board to delay this decision to allow for at least a few weeks to allow for public input into the process. That would also give the staff time to prepare a staff report that includes a more thorough analysis of options.

In 2020, Census takers risked their health and safety and overcame many other obstacles to complete the very important count that benefits all Americans. The data provided by the decennial Census results in funding for all levels of education beginning with preschool through university level, health centers on reservations, in rural areas and in high density metropolitan cities, public infrastructure which creates good jobs, mental health centers which are critical resources in times of need as well as many other government projects aimed at providing housing, ensuring food security and promoting public safety.

It is for this reason that I strongly urge that the Fresno County Board of Supervisors appoint a citizens advisory committee to work with county staff on local redistricting. There is a time constraint challenge this year, however, many other California counties and communities are forming or have formed citizen advisory bodies.

Dear Honorable Supervisors,

As we know, every ten years after the completion of the U.S. Census, all local jurisdictions in California are required to redraw their boundaries to reflect new population counts and ensure compliance with state and federal law.

There are many changes and new rules for California's local agencies in the redistricting process this time around. Because of delays related to COVID-19, data won't be available until September 30. Because of the delays caused by the pandemic, the California Legislature passed AB1276 last year, extending the local redistricting timeline, as well as adding further requirements to the local redistricting.

The intent of the Fair Maps Act passed in 2019 is to create standardized redistricting criteria to better keep communities together and prevent partisan gerrymandering. The law also requires local agencies to hold public hearings on redistricting and alters the redistricting timeline to allow more opportunities for public participation in the map drawing process.

We respectfully request that your future agendas include at least one public work session on the 2021 redistricting process, to gather and utilize public input on your proposed process and the selection of a proposed consultant prior to their engagement by the County. We also look forward to the Board providing the opportunity for community members to define their own communities of interest, so the Board can consider those resident-identified parameters once Census data becomes available.

Attached is a proposed resolution that articulates a fair and inclusive redistricting process, built on best practices and state law (including AB 849 & AB 1276). We look forward to these provisions being included in your redistricting plan.

We stand ready to assist you as you carry out your responsibilities. Due to circumstances related to the pandemic, the time to launch that process is now.

### Resolution Calling For A Fair And Inclusive Redistricting Process for Fresno County

Whereas, Fresno County Supervisorial District boundaries must be redrawn in 2021 for the next 10 years, determining how communities are represented, address issues of common interest, and which neighborhoods are divided or consolidated; and in the past, there have been few requirements that redistricting be fair, transparent, and engage marginalized communities; and

Whereas, robust, safe, inclusive community engagement to develop district maps requires time and resources to ensure digital access, diverse schedules, translation services, meeting notice, and other requirements identified by best practices and AB 849 and 1276 (Bonta).

Therefore, Be it Resolved that League of Women Voters of Fresno County urges the Fresno County Board of Supervisors to allocate adequate resources and provide policy direction to ensure an equitable and transparent redistricting process consistent with AB 849 and AB 1276 and the best practice guide of the Asian Americans Advancing Justice—Asian Law Caucus Guide to Best Practices in Districting. Specifically, we expect that the 2021 Fresno County redistricting process will achieve the following goals:

- 1. Protect and maintain communities of interest;
- Include at least one public hearing regarding the proposed consultant who will develop the map(s);
- 3. Include at least one public hearing regarding the proposed outreach plan for the redistricting process;
- 4. Ensure the consulting firm and redistricting process as a whole offers accessible online and in person opportunities to provide input regarding communities of interest, impact of proposed lines, and other comments, questions, concerns, and ideas related to the proposed maps;
- 5. Include accessibility approaches that remove physical, technological, language, and other barriers to public participation including work schedules and family commitments;
- 6. Leverage the trusted messengers and communities of interest infrastructure put in place to ensure a complete census count, including engaging community volunteers;
- Include meetings before and after proposed maps are created and at least two other methods/opportunities for engagement accessible for each of the five districts;
- 8. Leverage the Municipal Advisory Councils, Interfaith Networks, and other existing network/neighborhood infrastructure to communicate the importance of and opportunity to participate in the redistricting process;
- 9. Provide adequate funding and personnel to accomplish these goals in partnership with community volunteers; and
- 10. Provide meeting notices at least two weeks in advance, including notices of applicable Supervisor and Committee meetings.
