Dear board,

This plan affects the whole community, but it specifically affects certain members of the community. Advocates who work with youth in the communicating are aware that there has been a lack of substantive community involvement in this plan. This plan has not been created with input from directly impacted youth, families, and communities. Those closest to the pain are closest to the cure. Their voice matters and we want a plan that reflects their wisdom, values, and experience.

I ask that the board take this into advisement and not just take public comment now, but direct for there to be outreach to the community and ask for the help of community groups like Barrios Unidos, Building Healthy Communities, Boys and Girls Club to help with successful outreach. Real and significant effort must be put in seeking info.

I understand that there is data used in this plan, but evidence based info is still no substitute for this feedback from those actually living here who can tell you the needs, weakness, and what would help.

I appreciate the state's intent to have a more holistic plan with juvenile that is more restorative, but we need to ensure that this plan here actually accomplishes these aims. We need a realignment of our care to children and to ensure that students don't end up in county jails because we want to see change in these children's lives and treat children more like children than convicts.

Restorative justice and trauma informed care should be the focus. The point of this plan is to give the Department of Health and Human services would take the children and give them support services and funding be given to the Community Based Organization.

I ask that the Department of Social Services and Community based Organizationsrun this and not have it run by the department of corrections. and ensure that those who are experts in these items have authority over the implementation of the proces. Programming for youth should prioritize CBO's and individuals who are directly impacted who are better equipped to provide trauma informed care and positive youth programming and mentorship. Probation officers who will serve as guards are not appropriate to provide such care/services.

The JJC staff cannot both serve as 'role models' while also holding the key to the cell. Contrary to the plan's belief of creating a healthy balance, this will be a major block for youth in their development and healing.

Trauma informed care for healing should absolutely be the focus and priority. Trauma-informed care should also acknowledge how youth (specifically youth of color) experience trauma from sources beyond their homes (ie. police, state violence, probation officers, correctional guards.

We need to reduce youth incarceration. This means giving youth the services, resources, and programming needed for them to heal from what led them to incarceration in the first place. The major focus on centering the reduction of recidivism, although important, minimizes the importance of prioritizing the healing and trauma-informed care youth crucially need.

The committee needs to ensure that while the state bills were intended to avoid incarcerating youth do not get sent to adult facilities.

Youth deserve healing centered care and nobody can get well in a cell.

Fresno county's DJJ realignment plan of holding youth in the juvenile hall for 2-4 years of confinement does the opposite of SB 823's intent to reduce youth incarceration.

Also, the intent of SB 823 is to reduce and then eliminate racial and ethnic disparities, but the draft realignment plan does not say anything about how Fresno is going to reduce disparities in its system. For example, 30% of Fresno county youth sent to DJJ were Black even though only 5% of Fresno county youth are Black. This is not ok. Youth and community need to be engaged to design a plan to keep our Black and Brown youth connected to the communities that love them.

My name is Earl Aguilera and I am writing with regard to Agenda Item #7 for today's (April 27, 2021) meeting. I am an assistant professor at California State University, Fresno, though this message does not necessarily represent the views of my employer.

I would like to express my concern that Fresno County's realignment plan does not currently have specific provisions or a structured plan for how to address the inequitable arrests of Black and Brown youth. In solidarity with Fresno Barrios Unidos, 99Rootz, the Fresno Education Justice Collaborative, and the many youth and families calling for CARE, not cages.

Youth need healing-centered care; we know that <u>empirically, people do not "get better" in a cell</u>. Further, youth being the most directly impacted have not been consulted in the development of proposed changes. The JJC staff cannot serve as both 'role models' while also holding the key to a cell.Instead, youth programs should prioritize community based organizations / individuals who are directly impacted, and who are equipped to provide trauma informed care and positive youth programming / mentorship.
