IN THE AMOUNT OF \$5,000,000 )

WHEREAS, the County of Fresno, Facility Services, Organization (Org) 8935, requires an increase in appropriations in the amount of \$5,000,000 to allow for the ongoing payment of Job Order Contracting (JOC) capital and maintenance projects necessary to meet departmental demands and use;

WHEREAS, said additional costs will be financed by the revenue from user County Departments benefiting from said services in the amount of \$5,000,000;

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2020-21 Facility Services Org 8935 for this purpose; and,

WHEREAS, Government Code section 29130 provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors.

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2020-21 Facility Services, Org 8935 as follows:


