WHEREAS, the County Medical Services Org 5240 requires \$320,000 to meet expenditures associated with an unexpected high-cost claim for medical services processed by Advantek Benefit Administrators; and

WHEREAS, the County Medical Services Org 5240 will receive \$320,000 as an Operating Transfer In from the Local Health and Welfare Trust Fund 0135, Subclass 10000, Health Org 52430301; and

WHEREAS, said monies are not included in the FY 2020-21 adopted appropriations and estimated revenues of the County Medical Services Org 5240; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 County Medical Services Org 5240 as follows:




