IN THE MATTER OF AGRICULTURAL LAND CONSERVATION CONTRACT **RESOLUTION AUTHORIZING** RESCISSION OF AGRICULTURAL LAND CONSERVATION CONTRACT (ALCC) NOS. 1334 AND 5961 AND ENTRY INTO NEW AGRICULTURAL LAND CONSERVATION **CONTRACT NOS. 8338 AND 8339**

WHEREAS, Agricultural Land Conservation Contract (ALCC) No. 1334 was entered into between the County of Fresno and Paul D. Pafford and Cheryl C. Pafford, Trustees of The Pafford Revocable Living Trust, dated May 28, 2009, hereafter referred to as "Owner", and recorded February 26, 1970 as Instrument Number 13348, Book 5763, Pages 459 through 467 in the Official Records of Fresno County, California; and ALCC No. 5961 was entered into between the County of Fresno and Timothy R. Hall, Trustee of the Jason H. Hall Revocable Trust, dated August 11, 2016, hereafter referred to as "Owner", and recorded February 27, 1975 as Instrument Number 13818, Book 6402, Pages 673 through 676 in the Official Records of Fresno County, California; and

WHEREAS, Owners proposed adjusting parcel lines between a 124.81-acre parcel, identified as APN 006-170-18s, and a 123.15-acre parcel, identified as APN 006-170-05, resulting in an adjusted 125.4-acre parcel (adjusted Parcel A) and a 122.5-acre parcel (adjusted Parcel B). The rescission of existing Agricultural Land Conservation Contract Nos. 1334 and 5961 and simultaneous execution of new Agricultural Land Conservation Contract Nos. 8338 and 8339 is required to ensure the new contracts reflect the acreage of adjusted parcels; and

WHEREAS, Section 51257 of the California Government Code provides a process where parties may upon their mutual agreement rescind a contract in order to simultaneously enter into a new contract which would enforceably restrict the same property for an initial term at least as long as the unexpired term of the contract being so rescinded but no less than 10 years; and

WHEREAS, this rescission and re-entry would result in rescission of existing Agricultural Land Conservation Contract Nos. 1334 and 5961 and simultaneous entry into new Agricultural Land Conservation Contract Nos. 8338 and 8339.

NOW, THEREFORE IT IS HEREBY RESOLVED that the Board of Supervisors of the County of Fresno approves rescission of Agricultural Land Conservation Contract Nos. 1334 and 5961, and the simultaneous entry into Agricultural Land Conservation Contract Nos. 8338 and 8339, based on its ability to make the seven findings listed under Government Code Section 51257, and authorizes the Chairman to execute said contracts. The Clerk of the Board of Supervisors shall cause a certified copy of this resolution to be recorded together with the executed Contracts in the Office of the County Recorder for the County of Fresno.
