This Ordinance amends Chapter 2.72, entitled "Supervisorial Districts," of Title 2, entitled "Administration," of the Ordinance Code of Fresno County by amending Sections 2.72.010, 2.72.020, 2.72.030, 2.72.040, 2.72.050, 2.72.060, and 2.72.070 to provide for the establishment of supervisorial districts by ordinance or resolution.
