IN THE MATTER OF AGRICULTURAL LAND CONSERVATION CONTRACT RESOLUTION AUTHORIZING RESCISSION OF AGRICULTURAL LAND CONSERVATION CONTRACT (ALCC) NOS. 365, 1835, 1945, 1946, 4210 AND 4215 AND ENTRY INTO NEW ALCC NOS. 8340 AND 8341

WHEREAS, Agricultural Land Conservation Contract (ALCC) Number 365 was entered into between the County of Fresno and Giffen, Inc., a California Corporation, and succeeded to by Rusty Rose, LLC, a California Limited Liability Company, and Gonye Family Farms, LLC, a California Limited Liability Company, hereafter referred to as "Owner", and recorded February 27, 1969 as Instrument Number 13853, Book 5665, Pages 150 through 177 in the Official Records of Fresno County, California; and ALCC Number 1835 was entered into between the County of Fresno and Giffen, Inc., a California Corporation, and succeeded to by Gonye Family Farms, LLC, a California Limited Liability Company, hereafter referred to as "Owner", and recorded February 26, 1970 as Instrument Number 13953, Book 5765, Pages 53 through 54 in the Official Records of Fresno County, California; and ALCC Number 1945 was entered into between the County of Fresno and Burnell G. Forgey, and succeeded to by Rusty Rose, LLC, a California Limited Liability Company, and Gonye Family Farms, LLC, a California Limited Liability Company, hereafter referred to as "Owner", and recorded February 26, 1970 as Instrument Number 13855, Book 5764, Pages 744 through 748 in the Official Records of Fresno County, California; and ALCC Number 1946 was entered into between the County of

Fresno and Greta Forgey, and succeeded to by Rusty Rose, LLC, a California Limited Liability Company, and Gonye Family Farms, LLC, a California Limited Liability Company, hereafter referred to as "Owner", and recorded February 26, 1970 as Instrument Number 13854, Book 5764, Pages 739 through 743 in the Official Records of Fresno County, California; and ALCC Number 4210 was entered into between the County of Fresno and Texaco, Inc., a Delaware Corporation, and succeeded to by Gonye Family Farms, LLC, a California Limited Liability Company, hereafter referred to as "Owner", and recorded February 26, 1971 as Instrument Number 15972, Book 5869, Pages 655 through 656 in the Official Records of Fresno County, California; and ALCC Number 4215 was entered into between the County of Fresno and Ethel Gottstein and Mollie Gottstein Sable, and succeeded to by Gonye Family Farms, LLC, a California Limited Liability Company, hereafter referred to as "Owner", and recorded February 25, 1971 as Instrument Number 15008, Book 5867, Pages 926 through 928 in the Official Records of Fresno County, California; and

WHEREAS, Owners proposed Property Line Adjustment (PLA 20-37) to merge a total of 16 contracted parcels resulting in an adjusted 189.54-acre parcel and an adjusted 302.13-acre parcel. The rescission of existing Agricultural Land Conservation Contract Numbers 365, 1835, 1945, 1946, 4210 and 4215 and simultaneous execution of new Agricultural Land Conservation Contract Numbers 8340 and 8341 is required to ensure the new contracts reflect the acreage of adjusted parcels; and

WHEREAS, California Government Code Section 51257 provides a process where parties may upon their mutual agreement rescind a contract in order to simultaneously enter into a new contract which would enforceably restrict the same property for an initial term at least as long as the unexpired term of the contract being so rescinded but no less than 10 years, provided that the Board of Supervisors can make each of the seven (7) findings specified in said Section 51257; and

WHEREAS, this rescission and re-entry would result in rescission of existing Agricultural Land Conservation Contract Numbers 365, 1835, 1945, 1946, 4210 and 4215 and simultaneous entry into new Agricultural Land Conservation Contract Numbers 8340 and 8341.

NOW, THEREFORE IT IS HEREBY RESOLVED that the Board of Supervisors of the County of Fresno makes the following findings:

- The new contracts would enforceably restrict the adjusted boundaries of the parcels for an initial term for at least as long as the unexpired term of the rescinded contracts, but for not less than 10 years.
- 2. There is no net decrease in the amount of the acreage restricted. (In cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts.)
- At least 90 percent of the land under the former contracts remains under the new contracts.
- 4. After the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use.
- 5. The lot line adjustment would not compromise the long-term agricultural productivity of the parcels or other agricultural lands subject to contract.
- 6. The lot line adjustment is not likely to result in the removal of adjacent land from agricultural use.
- 7. The lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted parcel that is inconsistent with the General Plan.

IT IS FURTHER RESOLVED that the Board of Supervisors of the County of Fresno, hereby approves rescission of Agricultural Land Conservation Contract Numbers 365, 1835, 1945, 1946, 4210 and 4215, and the simultaneous entry into two new Agricultural Land Conservation Contract Numbers 8340 and 8341, based on its ability to make the seven findings required under Government Code Section 51257 and listed above, and authorizes the Chairman to execute said new contracts. The Clerk of the Board of Supervisors shall cause a
