I am writing to you to ask you to vote "No" on the attached Agenda Item 7: Acceptance of Non-Competitive Award Allocated by the California Department of Public Health. It seems like an innocuous agenda item, until you get to the middle of page three. If the County accepts this money from the State, it must try to accomplish the following goals:

- raise COVID-19 vaccination rates in the County Department of Public Health by 10%,
- raise COVID-19 vaccination rates in schools to 50% of students and 75% of faculty,
- raise COVID-19 vaccination rates in the county from 63% to 75%, and
- assist the 9 lowest vaccinated zip codes to achieve at least 50% vaccination over the next two years of this grant.
