SUPERVISOR BORGEAS PRESENTED A CONSTITUENTS CONCERN REGARDING TAX PAYMENTS. SUPERVISOR POOCHIGIAN EXPLAINED THAT MANY YEARS AGO TAX PAYMENTS WERE MADE TO THE DEPARTMENT NAME, BUT THE TAX COLLECTORS ASSOCIATION MADE A DECISION THAT THEY COULD BE MORE LENIENT AND THE TAX COLLECTORS COULD BEGIN TO USE THEIR PERSONAL NAME. SHE RECOMMENDS NOW WOULD BE THE APPROPRIATE TIME TO MAKE THE SWITCH BACK TO THE DEPARTMENT HEAD OR THE COUNTY NAME SINCE THERE IS CURRENTLY A CHANGE TAKING PLACE FOR THE DEPARTMENT HEAD. SUPERVISOR BORGEAS THANKED COUNTY COUNSEL FOR THE INFORMATION THAT WAS PROVIDED IN REGARDS TO A DEPARTMENT THAT HE AND SUPERVISOR PACHECO HAD REQUESTED. SUPERVISOR BORGEAS DIDN'T REALIZE THAT THERE WERE SO MANY BILLABLE HOURS AND A THIRD OF COUNTY COUNSEL'S LEGAL STAFF HAS BEEN DEVOTED TO ONE DEPARTMENT. SUPERVISOR POOCHIGIAN VOICED THANKS TO VICKI CROW FOR HER MANY. MANY YEARS OF SERVICE TO FRESNO COUNTY AND WISHED HER THE BEST IN HER RETIREMENT. SUPERVISOR POOCHIGIAN ASKED THAT THE SIGN BY HER NAME PLATE BE SHOWN ON CAMERA AS SHE TOLD THE ELEMENTARY STUDENTS THAT IT WOULD BE.
