SUPERVISOR MAGSIG REPORTED THAT AS OF JUNE 2018 THE FOREST MANAGEMENT TASK FORCE, FORMED THROUGH THE GOVERNOR'S OFFICE, REPLACES THE TREE MORTALITY TASK FORCE. DISTRICT FIVE AND THE DEPARTMENT OF PUBLIC HEALTH ARE HEAVILY INVOLVED WITH THIS TASK FORCE. SUPERVISOR MAGSIG STATED THAT THE AUDIT COMMITTEE CALLED A SPECIAL MEETING, ON JULY 27TH, TO RESPOND TO SOME OF THE COMMENTS THE GRAND JURY ISSUED IN THEIR RECENT REPORT. SUPERVISOR ANNOUNCED HE IS STEPPING DOWN FROM LAFCO EFFECTIVE THE END OF JULY AND FEELS IT'S IMPORTANT FOR THE CHAIRMAN TO MAKE A RECOMMENDATION TO FILL THE POSITION. HE THINKS SUPERVISOR PACHECO WOULD DO A FANTASTIC JOB IF HE CHOOSES TO ACCEPT THE POSITION. SUPERVISOR MAGSIG WILL BE ATTENDING THE NATIONAL ASSOCIATION OF COUNTIES CONFERENCE THIS WEEK REPRESENTING FRESNO COUNTY. SUPERVISOR MAGSIG ALSO ACKNOWLEDGED THAT THE BOARD WILL BE ADJOURNING IN MEMORY OF CARMELA ROBERTA WHO WAS A LONGTIME RESIDENT OF CLOVIS AND HAD A HUGE IMPACT ON THE CITY OF CLOVIS. HE STATED THAT IT IS A TRAGIC STORY AND WE SHOULD ALWAYS BE REMINDED OF HOW IMPORTANT IT IS TO VALUE LIFE. SUPERVISOR PACHECO EXPRESSED ON BEHALF OF THE BOARD CONDOLENCES FOR MICHELLE SANABRIA WHO PASSED AWAY EARLY SATURDAY MORNING, JUNE 30TH IN A TRAFFIC ACCIDENT. MICHELLE BEGAN WORKING FOR THE COUNTY IN 1998 AND WAS PROMOTED TO A SUPERVISING CHILD SUPPORT OFFICER IN 2008. SHE ALWAYS HAD A SMILE ON HER FACE AND HER FACE WOULD LIGHT UP WHEN SHE SPOKE OF HER TWO SONS. SHE WILL BE MISSED BY THOSE WHO WORKED WITH HER AND IT WILL BE A SAD PASSING OF OUR FRESNO COUNTY FAMILY. CHAIRMAN QUINTERO RECOGNIZED THE PASSING OF A FORMER FRESNO COUNTY EMPLOYEE LYDIA JEAN KUHN, WHO WORKED FOR 33 YEARS WITH THE COUNTY AND WAS WITH THE LIBRARY. SHE LOVED HER JOB AND IN RETIREMENT SHE JOINED THE ORGANIZATION FRIENDS OF THE LIBRARY WHERE SHE WAS VERY ACTIVE IN PROMOTING FUNDRAISING EFFORTS FOR THE LIBRARY. CHAIRMAN ALSO ACKNOWLEDGED ALBERTO NEITO WHO PASSED AWAY LAST WEEK. HE WAS ONE OF THE FIRST MEXICAN-AMERICANS TO GRADUATE FROM FRESNO STATE UNIVERSITY AND HE WAS AN EDUCATOR AND A FARMER. HE WAS VERY ACTIVE IN THE COMMUNITY PROMOTING MANY ACTIVITIES AND SERVICES FOR THE UNDERSERVED PEOPLE AND FAMILIES. HE WILL BE GREATLY MISSED AS HE WORKED HARD IN PROMOTING JUSTICE FOR EVERYBODY
