CHAIRMAN MAGSIG CONGRATULATED SUPERVISOR PACHECO ON HIS BROWN SWISS COWS. SUPERVISOR PACHECO THANKED CHAIRMAN FOR HIS COMMENTS AND REPORTED HE RECENTLY COMPETED IN THE WORLD DAIRY EXPO WHERE ONE OF HIS HEIFERS WON ITS CLASS AND WAS NAMED JUNIOR CHAMPION OF THE SHOW, WHICH MEANS IT IS THE TOP RATED HEIFER IN THE UNITED STATES, AND ANOTHER OF HIS COWS REPEATED LAST YEAR'S WIN IN ITS CLASS. SUPERVISOR MENDES ANNOUNCED THAT THE CARUTHERS FAIR, WHICH IS THE BIGGEST FREE GATE FAIR IN CALIFORNIA, WAS A BIG SUCCESS, WITH THE SHERIFF'S DEPARTMENT HELPING WITH THE OVERALL SECURITY OF THE FAIR. SUPERVISOR BRANDAU REPORTED THAT THE CALIFORNIA TRANSPORTATION COMMISSION (CTC) WAS MEETING IN MODESTO TODAY TO DISCUSS PROJECTS THE CALIFORNIA GAS TAX IS FUNDING. GOVERNOR NEWSOME RECENTLY SIGNED AN EXECUTIVE ORDER TAKING GAS TAX DOLLARS AWAY FROM ROAD PROJECTS AND INTO RAIL PROJECTS INCLUDING TWO PROJECTS THAT AFFECT THE CENTRAL VALLEY – THE WIDENING OF HIGHWAY 99 IN MADERA AND TULARE COUNTIES. THE CTC HAS TO FINALIZE THEIR DECISION ON PROJECTS BY NOVEMBER 15, 2019. SUPERVISOR BRANDAU SUGGESTED A LETTER TO CTC, FROM THE BOARD, REQUESTING A MEETING BE HELD IN FRESNO COUNTY SO THE CITIZENS IMPACTED BY THE CHANGES CAN VOICE THEIR CONCERNS. DIRECTION WAS PROVIDED THAT STAFF PREPARE THE LETTER IN THE NEXT FEW DAYS FOR CHAIRMAN MAGSIG AND SUPERVISOR BRANDAU'S SIGNATURES. CHAIRMAN MAGSIG THANKED FRESNO COUNTY AND COLLEAGUES FOR ATTENDING THE STATE OF THE COUNTY LUNCHEON. CHAIRMAN MAGSIG STATED HE HAD THE PLEASURE OF MEETING WITH TOMOCHIKA UYAMA, THE CONSUL GENERAL OF JAPAN, WHERE THEY DISCUSSED JAPAN'S PRIORITIES, AS WELL AS THE TRADE BETWEEN JAPAN AND FRESNO COUNTY AGRICULTURE
