**Description:**

Plaintiff alleges that his constitutional due process right to a speedy trial was violated as a result of delays by his appointed defense counsel in bringing him to trial on allegations that he was a sexually violently predator and that County officials were deliberately indifferent to the delay, which was the proximate cause of the claimant's injuries/damages.
