WHEREAS, Section 2121 of the Streets and Highways Code provides that in May of each year, each County shall submit to the California Department of Transportation any additions to or subtractions from its mileage of maintained County roads, specifying the termini and mileage of each route added or subtracted; and

WHEREAS, the Department of Transportation certified to the State Controller in the year 2024 that the total mileage of maintained Fresno County roads for the year ending December 31, 2023 was approximately 3,473.770 miles.

NOW THEREFORE IT BE RESOLVED, that the total mileage of maintained County roads as of December 31, 2024 be declared as approximately 3,466.146 miles, in accordance with the adjustments to the tabulation marked Exhibit A, and as indicated on the set of map excerpts marked Exhibit B. Both Exhibits are hereby incorporated as a part of this Resolution by reference thereto.

BE IT FURTHER RESOLVED AND ORDERED, that duplicate copies of the hereinabove said Exhibits A and B shall be filed in the office of the Director of the Department of Public Works and Planning of the County of Fresno.

BE IT FURTHER RESOLVED AND ORDERED, that the Director of the Department of Public Works and Planning or his designee is hereby authorized and directed to transmit a copy of this Resolution to the California Department of Transportation.
