12 **WHEREAS**, the Probation Org 34409999 requires \$20,037 to pay for one TekNET and
13 body scanner software, that were approved for purchase under Agreement No. A-25-196; and

14 **WHEREAS**, \$20,037 is available in the fund balance of the Juvenile Facility Grant Fund
15 0075, Subclass 17306, Org 1146; and

16 **WHEREAS**, Probation Org 34409999 will receive funds as an Operating Transfer In from
17 the Juvenile Grant Fund Org 1146; and

18 **WHEREAS**, said monies are not included in the FY 2025-26 adopted appropriations and
19 estimated revenues of the Probation Org 34409999; and

20 **WHEREAS**, Section 29130 of the Government Code provides for the appropriation of
21 these funds by a four-fifths vote of the Board of Supervisors;

22 NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector
23 is authorized to increase the appropriations in the FY 2025-26 Probation Org 34409999 as follows:
