RESOLUTION

WHEREAS, the Recommended Budget for the County of Fresno, State of California, for the Fiscal Year 2025-26, excluding special districts (“Recommended Budget”), has been prepared, made available to the public, and publicly distribute according to law;

WHEREAS, notice that the Recommended Budget has been so prepared, made available to the public, and publicly distributed, specifying the time and place of the Board of Supervisors’ public hearing upon the Recommended Budget for the purpose of fixing the Final Budget for the County of Fresno for Fiscal Year 2025-26, excluding special districts (“Final Budget”), has been published on September 3, 2025 in *The Business Journal* and in the *Fresno Bee* for such time and place in the manner required by law;

WHEREAS, the public hearing upon the Recommended Budget was held by the Board of Supervisors, commencing September 15, 2025, as described in such published notices of public hearing, at which public hearing items of the Recommended Budget were considered and discussed and all additions and deletions to the Recommended Budget were made;

WHEREAS, the public hearing upon the Recommended Budget having been continued from day to day, as necessary, all members of the public having been given the opportunity to appear at the public hearing and be heard regarding any item in the Recommended Budget or for the inclusion of additional items, and there being no requests or applications on file with the Board of Supervisors for further public hearing thereon, the Board of Supervisors declared such public hearing concluded and closed the public hearing;

1           WHEREAS, the Final Budget includes all adjustments to appropriations, revenues, and  
2 obligated fund balances made to the Recommended Budget during the budget hearing;

3           WHEREAS, the Recommended Budget, as adjusted by the Board of Supervisors at the  
4 conclusion of the public hearing upon the Recommended Budget, contains and meets all the  
5 specific requirements of Government Code section 29089.

6           NOW, THEREFORE, BE IT RESOLVED that the Recommended Budget for the County of  
7 Fresno for the Fiscal Year 2025-26, as amended during the public hearing upon such  
8 Recommended Budget, be and is hereby adopted as the Final Budget for the County of Fresno  
9 for the Fiscal Year 2025-26 for all funds (excluding special districts) governed by the Board of  
10 Supervisors (collectively, the "Final Budget"), which document is hereby adopted by reference,  
11 as provided for the Government Code section 29090, and made a part of this Resolution.

12           BE IT FURTHER RESOLVED that the Auditor-Controller/Treasurer-Tax Collector shall  
13 publish the Final Budget, as well as file the Final Budget as provided for in Government Code  
14 Section 29093.


