WHEREAS, additional appropriations are required by Public Works & Planning, Water & Natural Resources Org 43600300 to provide funding for expenditures related to disbursement of mitigation impact fees; and

WHEREAS, the Department of Public Works & Planning, Water & Natural Resources Org 43600300 will be reimbursed for expenditures related to disbursement of mitigation impact fees from Special Revenue Fund (SRF) 0088 – Public Facility Fees; and

WHEREAS, said monies are not included in the FY 2025-26 adopted appropriations and estimated revenues of the Public Works & Planning, Water & Natural Resources Org 43600300; and

WHEREAS, section 29130 of the Government Code provides for the appropriations of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2025-26 Budget for the Public Works & Planning, Water & Natural Resources Org 43600300 as follows:
