WHEREAS, the Del Rey Community Service District adopted Resolution No. 2025-6 on June 24, 2025 calling for a Special Election, followed by Resolution No. 2025-9 on August 7, 2025 requesting the Fresno County Clerk/Registrar of Voters conduct the November 4, 2025 Del Rey Community Service District Special Election and canvass the returns; and

WHEREAS, in Resolution No. 2025-9, the Del Rey Community Service District shall reimburse the County Clerk/Registrar of Voters for all costs incurred by said services.

NOW THEREFORE, BE IT RESOLVED:

- The Board of Supervisors authorizes the Fresno County Clerk/Registrar of Voters to conduct the November 4, 2025 Del Rey Community Service District Special Election.
- The Board of Supervisors authorizes the County Clerk/Registrar of Voters to bill the Del Rey Community Service District for their costs related to the conduct of the November 4, 2025
 Special Election and the Del Rey Community Service District to reimburse the County for such costs.
