RESOLUTION NO. 2025 - 9

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE DEL REY COMMUNITY SERVICE DISTRICT, CALIFORNIA REQUESTING THAT THE FRESNO COUNTY BOARD OF SUPERVISORS CALL FOR A SPECIAL ELECTION ON NOVEMBER 4, 2025 CALLING FOR THE PURPOSE OF ELECTING ONE (1) MEMBER OF THE BOARD OF DIRECTORS FOR SEAT B; AND REQUESTING THAT THE BOARD OF SUPERVISORS AUTHORIZE THE COUNTY CLERK TO CONDUCT THE ELECTION

WHEREAS, the Del Rey Community Service District, a special district under California law ("District"), was formed with a five-member Board of Directors ("Board") elected at large, with terms of office set pursuant to Government Code section 61021; and

WHEREAS, Government Code section 61021(c) states that "elections and terms of office shall be determined pursuant to Uniform District Law, Part 4 (commencing with Section 10500) of the Elections Code"; and

WHEREAS, in the Consolidated Municipal Election held on November 8, 2022, three Board members were elected: Joaquin Nunez Escutia, Daniel Ramirez, and Maria Reyna; and

WHEREAS, on September 19, 2024, prior to the conclusion of the regular meeting of the Board, Maria Reyna, the holder of Seat B, resigned as a member of the Board; and

WHEREAS, on June 24, 2025, the Board adopted Resolution 2025-6, calling for an election to fill the vacancy for Seat B, to take place on November 4, 2025; and

WHEREAS, the Board desires to have the Fresno County Board of Supervisors call a special election to be held in the District on November 4, 2025.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Del Rey Community Service District as follows:

- 1. The above recitals are true and correct and incorporated herein; and
- 2. The District's Board of Directors hereby requests that the Fresno County Board of Supervisors call a special election to be held in the District on November 4, 2025 to fill the vacancy for Seat B; and
- 3. The District's Board of Directors request that the Fresno County Board of Supervisors authorize the Fresno County Clerk to conduct the special election. The District will reimburse the County for the actual costs incurred by the County election officials in conducting the vote on the election upon the receipt of a bill stating the amount due as determined by the election official.

- 4. The District's Board of Directors requests that the election be conducted as a consolidated election on November 4, 2025.
- 5. The District Manager and/or District Counsel is hereby directed to file a certified copy of this resolution with the Board of Supervisors and the Elections Division of the County Clerk, Recorder, and Assessor and Registrar of Voters, of the County of Fresno.
