AN ORDINANCE AMENDING SECTION 4300 – INFORMATION TECHNOLOGY SERVICES OF THE MASTER SCHEDULE OF FEES, CHARGES, AND RECOVERED COSTS FOR THE COUNTY OF FRESNO, BY DELETING SUBSECTIONS 4301, 4303 AND 4322 AND AMENDING SUBSECTIONS 4302, 4304-4305, 4308-4310, 4313-4315, 4317, 4320-4321, 4323 AND 4326-4330, ARE AMENDED TO REVISE VARIOUS FEES.

The Board of Supervisors of the County of Fresno ordains as follows:

**Section 1.** The Master Schedule of Fees, Charges and Recovered Costs for the County of Fresno, Section 4300 – Information Technology Services, is hereby amended, by deleting subsections 4301, 4303 and 4322, and amending subsections 4302, 4304-4305, 4308-4310, 4313-4315, 4317, 4320-4321, 4323 and 4326-4330, relating to the recovery of costs for Information Technology Services of the Information Technology Services Department (ITSD) to public agencies, as set forth in Exhibit A, attached hereto and incorporated herein by reference.

**Section 2.** This ordinance shall take effect thirty (30) days from the date of its final passage.
