 11 RESOLUTION IN THE AMOUNT OF \$456,981)

12 WHEREAS, the Aid to Adoptions Org 6415 will receive \$456,981 in revenues as an
 13 Operating Transfer In from the Welfare Advance Fund Org 1120 in the amount of \$250,906, the
 14 1991 Realign–Social Services Org 5246 in the amount of \$51,595, and the Protective Services
 15 Subaccount Org 6210 in the amount of \$154,480; and

16 WHEREAS, said monies were not included in the FY 2025-26 adopted appropriations and
 17 estimated revenues of the Aid to Adoptions Org 6415 for this purpose; and

18 WHEREAS, Section 29130 of the Government Code provides for the appropriation of these
 19 funds by a four-fifths vote of the Board of Supervisors;

20 NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is
 21 authorized to increase the appropriations in the FY 2025-26 Aid to Adoptions Org 6415 follows:
