10 WHEREAS, the Fresno County Sheriff will receive \$55,980 for miscellaneous equipment
11 (Radio siren/PA controller, two (2) Rescue Sleds Repower-Replacement of motor, gauges,
12 steering, bow lights, shift and throttle, chairs, depth finder, flooring, small trolling type motor, swim
13 step, bimini top, and engine covers) from the State of California Department of Parks and
14 Recreation Division of Boating and Waterways; and

15 WHEREAS, said monies are not included in the appropriations and estimated revenues of
16 the Sheriff-Coroner-Public Administrator Org 3111 for Fiscal Year 2025-26; and

17 WHEREAS, Section 29130 of the Government Code provides for the appropriation of
18 these funds by a four-fifths vote of the Board of Supervisors;

19 NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector
20 is authorized to increase the appropriations in the Fiscal Year 2025-26 Sheriff-Coroner-Public
21 Administrator Org 3111 as follows:
