7	WHEREAS, on March 2, 2023, the Emergency Services Director of the County of Fresno		
8	proclaimed the existence of a local emergency as a result of extreme weather conditions beginning		
9	on February 23, 2023, including unprecedented snowfall, flooding, and infrastructure impacts		
10	affecting multiple communities in Fresno County; and		
11	WHEREAS, on March 7, 2023, the Board of Supervisors ratified the proclamation and		
12	adopted a resolution confirming the existence of a local emergency; and		
13	WHEREAS, the Governor of the State of California proclaimed a State of Emergency on		
14	March 1, 2023, and on April 14, 2023, Fresno County was included in the Presidential Emergency		
15	Declaration; and		
16	WHEREAS, the February 2023 Winter Storms caused hazardous conditions requiring		
17	emergency response and protective measures, including road closures, shelter operations, and		
18	utility restoration; and		
19	WHEREAS, Government Code §8630 and Fresno County Ordinance Chapter 2.44 require		
20	the Board of Supervisors to proclaim the termination of a local emergency at the earliest possible		
21	date when conditions warrant; and		
22	WHEREAS, the emergency response phase has concluded, all eligible projects have been		
23	identified and submitted to FEMA for review, and termination of the emergency status will not affect		
24	continued recovery operations;		
25	NOW, THEREFORE, IT IS HEREBY PROCLAIMED by the Board of Supervisors of the		
26	County of Fresno, State of California, that said local emergency is terminated; and		
27	IT IS FURTHER ORDERED that a copy of this Resolution be forwarded to the State		
28	Director of the Office of Emergency Services.
