10 WHEREAS, the Medi-Cal – HHIP & IPP Org 0129 requires \$343,089 to meet
11 expenditures; and

12 WHEREAS, the Medi-Cal – HHIP & IPP Org 0129 requires appropriations to fund an
13 Operating Transfer Out in the amount of \$343,089 to the Office of Housing and Homelessness
14 Org 5428; and

15 WHEREAS, sufficient funding is available through the Agreement with Managed Care
16 Plans for Medi-Cal Grant in the amount of \$343,089; and

17 WHEREAS, said monies are not included in the FY 2025-26 adopted appropriations and
18 estimated revenues for Medi-Cal – HHIP & IPP Org 0129; and

19 WHEREAS, Section 29130 of the Government Code provides for the appropriation of
20 these funds by a four-fifths vote of the Board of Supervisors;

22 NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector
23 is authorized to increase appropriations in the FY 2025-26 Medi-Cal – HHIP & IPP Org 0129 as
24 follows:
