11 WHEREAS, funds are needed to cover expenditures related to the administration of the
12 Agreement with local Managed Care Plans for Medi-Cal Grant funding; and

13 WHEREAS, \$343,089 will be available in the FY 2025-26 estimated revenues of the
14 Housing and Homelessness Fund 0023, Subclass 17129 Medi-Cal – HHIP & IPP Org 0129 to
15 fund these expenditures; and

16 WHEREAS, the Office of Housing and Homelessness Org 5428 will receive funds as an
17 Operating Transfer In from the Medi-Cal – HHIP & IPP Org 0129; and

18 WHEREAS, said monies are not included in the FY 2025-26 adopted appropriations and
19 estimated revenues of the Office of Housing and Homelessness Org 5428; and

20 WHEREAS, Section 29130 of the Government Code provides for the appropriation of
21 these funds by a four-fifths vote of the Board of Supervisors;

22 NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector
23 is authorized to increase the appropriations in the FY 2025-26 Office of Housing and
24 Homelessness Org 5428 as follows:
