AN ORDINANCE AMENDING SECTION 900 – ENVIRONMENTAL
HEALTH OF THE MASTER SCHEDULE OF FEES, CHARGES, AND
RECOVERED COSTS FOR COUNTY OF FRESNO, WHERE ANIMAL
CONTROL SUBSECTION 905 IS ADDED AND REVISE NUMBER
SEQUENCE OF SECTIONS 905 THROUGH 961.

The Board of Supervisors of the County of Fresno ordains as follows:

Section 1. The Master Schedule of Fees, Changes, and Recovered Costs for the
County of Fresno, Section 900 – Environmental Health, is hereby amended, by adding
section 905 for the provision of new rooster keeping permit, and revise numbering
sequence 905 through 961, to read in its entirety as set forth in Exhibit A, attached
hereto and incorporated by this reference.

Section 2. This Ordinance shall take effect no less than thirty (30) days after final
passage.
