ANNUAL BENEFIT ASSESSMENTS FOR) RESOLUTION
FRESNO COUNTY SERVICE AREA NO. 50)

WHEREAS, the Board of Supervisors (Board) formed County Service Area No. 50 (CSA 50) in 2003 to provide fire protection and emergency medical services for the unincorporated community of Auberry; and

WHEREAS, the facilities and services proposed to be provided by the County in CSA 50 include fire protection and emergency medical response services; an operations and maintenance reserve; capital replacement needs; and costs associated with administering assessments, financial audit requirements, liability insurance, and other administrative costs (collectively, Fire Protection and Emergency Medical Services); and

WHEREAS, Government Code Section 50078 et seq. authorizes the County to impose benefit assessments in CSA 50 to pay for the costs of Fire Protection and Emergency Medical Services; and

WHEREAS, Steven E. White (Assessment Engineer), who is registered under the Professional Engineers Act (Division 3, Chapter 7 of the California Business and Professions Code, beginning with Section 6700), has prepared a written report, titled "County Service Area 50 Benefit Assessment, Final Engineer's Report," (Engineer's Report);

WHEREAS, the Engineer's Report complies with Article XIII D, Section 4, of the California Constitution and Government Code Section 50078 et seq., and includes (1) a description of the assessment and the method by which it will be imposed; (2) a compilation of the amount of the assessment proposed for each parcel subject to the assessment; (3) a statement of the methodology and rationale followed in determining the degree of special benefit conferred by the services for which the assessment is made; and (4) other factors required by Government Code Section 50078.4 and 50078.5;

WHEREAS, the Engineer's Report is on file with the Clerk of the Board of Supervisors;

WHEREAS, a description of the lands upon which the assessment is to be imposed is provided

1 in Exhibit A to this resolution;

2 WHEREAS, the amount of the assessment to be imposed is as stated in Exhibit B to this
3 resolution, which is a roll of the proposed assessment;

4 NOW, THEREFORE, THE BOARD OF SUPERVISORS OF THE COUNTY OF FRESNO DOES
5 HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

6 **Section 1.** The above recitals are all true and correct.

7 **Section 2.** The Board hereby initiates proceedings under Government Code Section 50078
8 et seq. and Article XIII D of the California Constitution to levy and collect an annual benefit assessment
9 in CSA 50 for the costs of Fire Protection and Emergency Medical Services. The assessment shall be
10 imposed on the parcels identified in Exhibit A, at the amounts stated in Exhibit B.

11 **Section 3.** A public protest hearing (Public Hearing) on the proposed assessment is hereby
12 set for **June 30, 2026 at 9:30 A.M.**, or as soon after as practicable, in the Board Room of the Fresno
13 County Board of Supervisors, Room 301, Hall of Records, 2281 Tulare Street, Fresno, California, 93721,
14 for hearing all objections and protests to the proposed assessment as set forth in the Engineer's Report.
15 The Public Hearing shall be held under Section 53753 of the California Government Code. The Public
16 Hearing may be continued from time to time by the Board without further notice by the Board.

17 **Section 4.** The Board hereby authorizes and directs the Director of Public Works and
18 Planning (Director) or his designees to prepare the assessment ballots and assessment ballot
19 instructions, any materials for the change, withdrawal, or substitution of assessment ballots, including
20 substitute assessment ballots and substitute assessment ballot instructions, any materials for co-owner
21 assessment ballots and co-owner assessment ballots, and any other forms and materials, as the Director
22 or his designees deem necessary or appropriate, with respect to the submission of assessment ballots
23 by record property owners of the property within CSA 50, under Section 53753 of the California
24 Government Code.

25 **Section 5.** The Board hereby authorizes and directs the Director or his designee to prepare,
26 for the assessment, a notice of the Public Hearing (Notice). The Notice shall contain:

27 A. The date, time, and location of the Public Hearing;

28 B. The total amount of the proposed assessment chargeable to all of the affected parcels;

- 1 C. The amount of the proposed assessment for each affected parcel;
- 2 D. The basis upon which the amount of the proposed assessment was calculated;
- 3 E. A statement that the amounts of the assessment may change as stated in the Engineer's
- 4 Report;
- 5 F. The reason for the assessment;
- 6 G. The address to which property owners may mail ballots in support of or opposition to the
- 7 assessment;
- 8 H. The telephone number and address of an individual or office that interested persons may
- 9 contact to receive additional information about the assessment;
- 10 I. An assessment ballot for the assessment that includes the address for receipt of the ballot
- 11 and a place where the person returning the ballot may indicate his or her name, a reasonable
- 12 identification of the parcel, and his or her support or opposition to the assessment;
- 13 J. Assessment ballot instructions as described in Section 4 of this resolution; and
- 14 K. A statement that the assessment shall not be imposed if the ballots submitted in opposition to
- 15 the assessment exceed the ballots submitted in favor of the assessment, with ballots weighted
- 16 according to the proportional financial obligation of the affected property.

17 The Director or his designee shall deliver the Notices to the Clerk of the Board no later than May
18 12, 2026.

19 **Section 6.** The Board hereby authorizes and directs the Clerk of the Board (Clerk) to mail, no
20 later than May 16, 2026, the Notice (which shall include the assessment ballot and assessment ballot
21 instructions as described above in Section 4 of this resolution), to the record property owners of the
22 parcels to be assessed. On the face of the envelope in which the Notice is sent, there shall appear, in
23 no smaller than 16-point bold type, the words "OFFICIAL BALLOT ENCLOSED." Upon the Clerk's
24 completion of the mailing of the Notice, the Clerk is hereby directed to file with the Board an affidavit
25 setting forth the time and manner of the compliance with the requirements of this resolution for mailing
26 the Notice.

27 **Section 7.** If the Board imposes the assessment, the resolution imposing the assessment
28 shall provide that the amount of the assessment may change in successive years as stated in Exhibit B

1 to this resolution, and in the Engineer's Report. If new, increased, or extended assessments are
2 proposed, the Board will comply with the notice, protest, and hearing procedures in Government Code
3 Section 53753.

4 **Section 8.** If the Board imposes the assessment, the resolution imposing the assessment
5 shall provide that the assessment will be collected annually at the same time, and in the same manner,
6 and subject to the same penalties, as the general taxes of the County.

7 **Section 9.** If the Board imposes the assessment, the resolution imposing the assessment
8 shall provide that the Director is authorized and directed to timely deliver, or cause their designee to
9 timely deliver, to the Auditor-Controller/Treasurer-Tax Collector, for each fiscal year for which the
10 assessment is levied by this resolution, a true and complete roll of the assessment in the amounts
11 provided by Exhibit B to the levying resolution.

12 **Section 10.** The Board hereby finds and determines that it took all of the foregoing actions and
13 made all of the foregoing findings in full compliance with the law, including, without limitation, Government
14 Code Section 50078 et seq., Government Code Section 53753, Article XIII D of the California
15 Constitution, and any other law referred to in this resolution.

16 **Section 11.** The Director and his designees are hereby designated and authorized to tabulate
17 the assessment ballots (including substitute assessment ballots and co-owner assessment ballots)
18 submitted, and not withdrawn, in support of or opposition to the assessment referred to in this resolution.
19 Each of those persons may, in their discretion, appoint assistants, including, but not limited to, employees
20 of the County Administrative Office and the Office of the Clerk of the Board, to help tabulate the
21 assessment ballots (including substitute assessment ballots and co-owner assessment ballots). The
22 Board hereby finds and determines that each of the persons described in this Section 11 is an impartial
23 person who does not have a vested interest in the outcome of this assessment proceeding.

24 **Section 12.** This resolution shall take effect immediately upon its adoption.

Exhibit A – Boundary Description and Map

All those portions of the following U.S. Government Townships:

Township 9 South, Range 22 East, Range 23 East, Range 24 East, Range 24 East, Mount Diablo Base and Meridian also Township 10 South, Range 22 East, Range 23 East, Range 24 East and Range 25 East, Mount Diablo Base and Meridian, more particularly described as follows:

Parcel A

Beginning at the intersection of the centerline of the San Joaquin River and the East line of Section 16 of Township 10 South, Range 22 East, said centerline being also the County line common to Fresno and Madera Counties; thence leaving said County line and said centerline of the San Joaquin River, Southerly along the East line of the Northeast Quarter of said Section 16, to the Southeast corner thereof; thence Easterly along the North line of the Southwest Quarter of Section 15 of Township 10 South, Range 22 East, to the Northeast corner of the Northwest Quarter of said Section 15; thence Southerly along the East line of said Quarter-Section to the Southeast corner thereof; thence Easterly along the North line of the Southeast Quarter of said Section 14, to the Northeast corner thereof; thence Southerly along the East line of said Section to the Southeast corner thereof; thence Easterly along the North line of the North half of Section 24 of said Township 10 South, Range 22 East, to the Southeast corner thereof; thence Easterly along the North line of the Southwest Quarter of Section 30 of said Township 10 South, Range 23 East, to the Northeast corner thereof; thence Southerly to the East line of the Northeast Quarter of the Southwest Quarter of said Section 30, to the Southeast corner thereof; thence Easterly along the North line of the South half of said Section to the Northeast corner of said Section 30; to the Northeast corner thereof; thence Southerly along the East line of the South half of said Section to the North line of the South half of said Section 24, Township 10 South, Range 23 East, to the Southeast corner thereof; thence Easterly along the South line of said Section to Highway 168, to the North line of the Northeast Quarter of the Southeast Quarter of said Section to the Northwest corner thereof; thence Easterly along said North line to the Northeast corner thereof; thence Easterly along the North line of the Northwest Quarter of said Section 19, Township 10 South, Range 23 East, to the Northeast corner thereof; thence Southerly along the East line of said Quarter-Section to the Southeast corner thereof.

Thence Westerly along the South line of said Section to the Northeast corner of scenic Highway 168 right-of-way; thence continuing Northerly along said 168 right-of-way to Road 225 (Future State Highway 168 Alignment) as approved by Tract Map 5257; thence Southeasterly along the Road 225 right-of-way to the intersection with the North line of Section 21, to a point thereon; thence leaving said Right of Way line and continuing Easterly along said North line to the

Northeast corner of said Section 21; thence Southerly along the East line of said Section to the Southeast corner thereof; thence Easterly along the North line of Section 28 and Section 27, Township 10 South, Range 23 East, to the Northeast corner of said Section 27; thence Southerly along the East line of said Section 27 to the Southeast corner thereof; thence Easterly along the North line of Section 34, T10S, R23E, to the Northeast corner thereof; thence Southerly along the East line of said Section 34 to the intersection with the centerline of the San Joaquin River to the Point of Beginning.
